Order

Sri T. Poshetty, Kamareddy District has filed 2nd appeal dated: 22-10-2020 which was received by this Commission on 28-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Yellareddy Mandal, Kamareddy District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Yellareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 07-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I submit that I am T. Poshetty (50/64 yrs aged) of Bamsado and also President, Chayula Bera Sangam (Rural) filing this RTI Appl. u/s 6(1)/6(3) of the Act with Rs 10/- court fee stamp towards app. fee for the following information/ records of Sr. R. Dhanunjay, VRO Yellareddy (Mdl) Dist. Kamareddy (TS) on the points mentioned hereunder to file Money Recovery/Criminal Suit of my paid cheque Rs. 2 (Two) lakhs from his salary/property attachment against such sums charges payable to me as vote made of interest agreed/promised there in for the last 2 1/2 years in limitation besides Dept/Service Rules below is of Sr. R. Dhanunjay, VRO Yellareddy (Mdl) & his office.

- i) His 1st appointment order copy in revenue or other Dept. service/cadre.
- ii) His present posting by transfer orders to Yellareddy (Mdl)
- iii) His DOB/BOR, date of birth and date of retirement with Educational/Dept Qualifications (Dept. Tests etc).
- iv) List of villages/hamlets of his cluster with all VRO's of Mandal by phone nos
- v) Duty/Job chart of him as VRO
- vi) List of VRA's with phone nos of his cluster villages.
- vii) List of FPS deduct/Name with phone nos of his cluster
- viii) List of GP staff names with phone nos of his cluster
- ix) List of other all Govt Dept. Staff names with phone nos of his cluster.
- x) His Monthly pay slip/Salary statement of April, 2020.
- xi) His office attendance Register for April 2020 for sign proof along with separate sheet of Specimens Signature.
- xii) His Annual property statement for 2019-20 filing /filed in due month Jan/April 2020.
- xiii) His appointing/ disciplinary/ controlling authority name & designation with phone No & mail.
- xiv) Any private/Govt - Dept/ disciplinary cases disposed/pending.
- xv) General opinion of his conduct & character with officiating fitness as VRO.

I therefore request to kindly arrange furnishing the information/records copies duly attesting sign in time to avoid time loss of Appeal even by transfer of s/o u/s 6(3) or so.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-06-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The appellant is absent, but filed his affidavit stating that the PIO has furnished the information. The PIO / Sri S. Swamy, Deputy Tahsildar, Yellareddy Mandal, Kamareddy District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: B/2359/2020 dated: 12-06-2020 and filed a copy of the information furnished along with the acknowledgement of the appellant before the Commission.

Heard both the parties and perused the material papers available on record and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
