Order

Sri M. Ashok Kumar, Secunderabad has filed 2nd appeal dated: 24-10-2020 which was received by this Commission on 28-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Yellareddy Mandal, Kamareddy District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Yellareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. **FULL NAME OF APPLICANT:** Musthyala Ashok Kumar S/o Venkataramaiah, R/O Yellareddy.
2. **ADDRESS:** 12-10-664, Indira Nagar, Roadno.2, Warasiguda, Secunderabad. PIN 500061. Mobile No: 9440021330
3. **PARTICULARS OF INFORMATION REQUIRED**
 - a) Please furnish a copy of records or documents or file notings in respect of Tahsil Memo No A2/853/1997 dated 18-04-2016. Implementation of decree in O.S 66/88 passed by Hon'ble Sub-Court, Bodhan.
 - b) Please supply a copy of records or documents or file notings in respect of Gandimasanipet Sy No 131& 132 extent of 2.15 ½ land 1B Pahani copies.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 22-08-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 27-08-2021 at 10.30 A.M.

The case is called on 27-08-2021. The appellant is present and stated that the PIO has not furnished the information. The PIO / Sri S. Swamy, Deputy Tahsildar, Yellareddy Mandal, Kamareddy District is present and requested to give time to furnish the information.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 29-06-2020 seeking information on 2 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri S. Swamy, Deputy Tahsildar, Yellareddy Mandal, Kamareddy District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the complete information duly attesting the same to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
