Order

Sri C. Maonhar, Nizamabad District has filed 2nd appeal dated: 23-10-2020 which was received by this Commission on 31-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Kamareddy Mandal & District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Kamareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 09-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. తేది. 31.06.2020 రోజున ఆర్.డి.వో. కామారెడ్డి గారు తహసీల్దారు కామారెడ్డి గారికి తన చాంబర్లో స్వయంగా ఇచ్చిన రెడ్డిపేట అంజనేయులుగారి దరఖాస్తు తేది 31.06.2020 గల దానిపై తమరు ఈ రోజు వరకు తీసుకున్న రోజువారీ చర్యల వివరాలు మొత్తం ప్రతులు జిరాక్స్ చేసి ప్రతిపేజీ ధృవీకరించి ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 26-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 08-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 08-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information.

The PIO / Sri. P.V. Srinivas, Deputy Tahsildar, Kamareddy Mandal, Kamareddy District responded and stated that the information was furnished to the appellant vide letter No: A/2413/2020 dated: 06-11-2020 and filed a copy of the information furnished before the Commission.

Heard both parties and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 09-09-2020 seeking information on the action taken on the compliant filed on 31-06-2020.

The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information once again to the appellant within One (1) week from the date of receipt of this order through Registered post acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
