Order

Sri. K. Somashekhar Rao, Hyderabad has filed 2nd appeal dated: 28-10-2020 which was received by this Commission on 02-11-2020 for not getting the information sought by him from the PIO / O/o the District Revenue Officer, Nizamabad Collectorate, Nizamabad District and 1st Appellate Authority / O/o the District Collector, Nizamabad Collectorate, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 15-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-07-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The appellant is present and stated that the PIO has not furnished the information. Sri B. Chandra Shekhar, Additional Collector, Nizamabad Collectorate, Nizamabad District is present and filed his affidavit stating that vide letter No: B3/746/2020 dated: 25-06-2020 the application was transferred U/s 6(3) of RTI Act 2005 to the PIO / O/o the District Co-Operative Officer, Nizamabad District with a direction to furnish the information to the appellant.

Heard both the parties and perused the material paper available on record and observed that the appellant through his 6(1) application dated: 16-06-2020 seeking certain information.

The Commission directs the PIO / O/o the District Co-Operative Officer, Nizambad District to furnish the complete information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
