## Order

Sri B. Vamsi Krishna, Rajana Sircilla District has filed 2<sup>nd</sup> appeal dated: 29-10-2020 which was received by this Commission on 02-11-2020 for not getting the information sought by him from the PIO / O/o the District Collector, Rajana Sircilla District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Rajana Sircilla District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-12-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

The Public Information Officer O/o the District Collector, Rajana Sircilla District vide Lr. No. H/2396/2019 dated. 05-02-2020 transferred the application U/s 6(3) of the RTI Act to O/o the District Women Development and Child Welfare, Rajana Sircilla District with a request to furnish the information to the appellant.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 23-01-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 16-09-2021 at 10.30 A.M.

The case is called on 16-09-2021. The appellant is absent, but informed over phone that he is in receipt of the information. The PIO / Sri P. Laxmi Rajam, District Welfare Officer, WCD & SC Rajanna Sirisilla District is present and stated that a reply was given to the appellant vide letter No: C/528/2019 dated: 05-01-2020 and on- receipt of the Commission notice dated: 24-08-2021 the information was once again furnished to the appellant vide letter No: C/528/2019 dated: 13-09-2021. The PIO filed a copy of the information furnished before the Commission.

Perused the material papers available on record and is of the view of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the complaint is closed.
