## Order

Sri P. Ramaprasad, Hyderabad has filed 2<sup>nd</sup> appeal dated: 12-06-2018 which was received by this Commission on 12-06-2018 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 13-11-2017 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

W.P. No. 9040 of 2014 కు సంబంధించి, వాది మరియు ప్రతివాదులచే దాఖలు చేయబడిన పత్రములు మరియు జారీ చేయబడిన Court వారి ఆదేశముల ప్రకారం, R.T.I. Act, Section 2 (j) (2) ప్రకారం, ప్రతి పుట ప్రతిని, ధృవీకరించి యివ్వవలసిందిగా కోరుచున్నాను.

దరఖాస్తు రుసుము విమిత్తం రు.10/- విలువ కలిగిన 43F 918193 నెంబరు గా Indian Postal Order ను యిందుకో జతపర్చడమైనది.

The PIO vide ROC No.884/PIO/JUDL/2017 dated: 17-11-2017 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 23-12-2017 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices are issued to both the parties for hearing on 03-09-2021 at 10.30 A.M.

The case is called on 03-09-2021. The appellant is absent. Sri Swaroop Oorilla, Standing Counsel and advocate on record for O/o the Registrar Judicial, High Court of Telangana, Hyderabad is present and submitted that a reply was given to the appellant vide letter ROC No: 884/PIO/JUDL/2017 dated: 17-11-2017 and on filing the 1<sup>st</sup> appeal dated: 23-12-2019 the First Appellate Authority vide order in appeal No: 211 of 2017 dated: 29-01-2018 passed an order informing the appellant has to pursue his legal remedy with regard to obtain the copy application and dismissed the appeal confirming the order of the SPIO.

Perused the material papers available on record. The appeal is devoid of merit and confirming the order of the PIO.

The appeal is closed.
