## Order

Sri A. Bhupathi Reddy, Mancherial District has filed 2<sup>nd</sup> appeal dated: 31-10-2020 which was received by this Commission on 03-11-2020 for not getting the information sought by him from the PIO / O/o the Revenue Divisional Officer, Bellampalli Division, Mancherial District and 1<sup>st</sup> Appellate Authority / O/o the Joint Collector, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 13-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 29-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 12:00 P.M.

The case is called on 17-09-2021. The appellant is present and stated that the then PIO has not paid the compensation amount as per the direction of the Commission in appeal No: 11509/CIC-R/2016 dated: 08-12-2016 and requested to take action against the PIO. The PIO / Sri D. Vamsheedhar Reddy, Deputy Tahsildar is present and filed affidavit of Smt. K. Shyamala Devi, Revenue Divisional Officer, Bellampally Division, Mancherial District stating that vide letter memo No: D/282/2021 dated: 23-04-2021 a detailed report has been submitted to the District Collector, Mancherial District informing that Sri K. Suresh, the then Tahsildar, Mancherial Mandal & District presently working as Administrative Officer, O/o the District Collector, Mancherial District is the incumbent Tahsildar at the time of filing the 6(1) application. The PIO filed a copy of the memo before the Commission.

Heard both the parties and perused the material papers available on record and observed that the Commission through appeal No: 11509/CIC-R/2016 dated: 08-12-2016 directed the PIO to pay the compensation amount to the appellant and accordingly Show Cause Notice was also issued to the PIO for not furnishing information. The appellant again filed 2<sup>nd</sup> appeal requesting to take action against the PIO for not paying the compensation amount which was awarded by the Commission. The Commission cannot accept the plea of the appellant to take penal action again and again on the same matter since the action was already taken by the Commission by issuing Show Cause Notice.

As per the submission of the Revenue Divisional Officer, Bellampally Division, Mancherial District that the then PIO / Sri K. Suresh, Tahsildar, Mancherial Mandal & District presently working as Administrative Officer, O/o the District Collector, Mancherial District is the incumbent Tahsildar at the time of filing the 6(1) application, the Commission directs the District Collector, Mancherial District to ensure that the compensation amount which was awarded by the Commission vide appeal No: 11509/CIC-R/2016 dated: 08-12-2016 be paid by the then PIO / Sri K. Suresh, Tahsildar, Mancherial Mandal & District presently working as Administrative Officer, O/o the District Collector, Mancherial District within 15 days of receipt of this order and report compliance to the Commission.

With the above direction, the appeal is closed.
