## **Order**

Sri N. Rajpreetham, Jagtial District has filed a Complaint dated Nil which was received by this Commission on 13-08-2019 for not getting the information sought by him from the PIO / O/o the Principal Junior Civil Judges Court, Madhira Mandal, Khammam District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 09-07-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

I Narmashetti RajPreetham s/o Venkataramana is here by request to furnish the Xerox copies of Service register and IT returns of N.Venkataramana

I am the son of Narmashetti Venkataramana copy of Aadhar card is enclosed.

Further, I also undertake to pay any additional charges/fees (if applicable) as prescribed under the RTI Act

Kindly provide the information as soon as possible and within time frame as stipulated under RTI Act 2005.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 17-09-2021 at 10.30 A.M.

The case is called on 17-09-2021. The complainant is absent. The PIO / Sri K.V. Krishna Mohan, Superintendent, O/o the Principal Junior Civil Judges Court, Madhira Mandal, Khammam District is present and stated that vide letter Dis. No: 469/19 dated: 27-07-2019 the application was rejected since the information sought is personal information and is exempted u/s 8(1) of the RTI Act 2005. The PIO filed a copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 09-07-2019 seeking the Service Register and the IT returns of his father Sri N. Venkataramana who is working as Junior Assistant in O/o the Principal Junior Civil Judges Court, Madhira Mandal, Khammam District and the PIO vide letter dated: 27-07-2019 informed that the information cannot be furnished as per Section 8 of the RTI Act 2005.

In view of the above, the complaint is closed.
