## **Order**

Sri K. Somashekhar Rao, Hyderabad has filed a Complaint dated 08-11-2020 which was received by this Commission on 11-11-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Banswada Mandal, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 26-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

2018-2019, 2019-2020, 2020-2021 ఆర్థిక సంవత్సరాలలో Banswada మండలములో ప్రభుత్వము వారు ఇచ్చు డబ్బుల్ బెడ్ రూమ్ మంజూరైన వారి సమాచారము గ్రామాల వారీగా పేరు తండ్రి పేరు /భర్త పేరు /గ్రామము/ మంజూరైన తేదీ సంవత్సరము లాంటి సమాచారము అందించగలరు

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 06-08-2021 at 10.30 A.M.

The case is called on 06-08-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri B. Ramdas, Deputy Tahsildar, Banswada Mandal, Kamareddy District is present and filed his affidavit stating that the information was furnished to the complainant vide letter No: D/273/2021-8 dated: 30-07-2021 and filed the copies of the information furnished along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 26-08-2020 seeking information on 2 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the then PIO / Sri K. Gangadhar, Deputy Tahsildar, Banswada Mandal, Kamareddy District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the complaint is closed.
