## **Order**

Sri. K. Somashekhar Rao, Hyderabad has filed a Complaint dated: 08-11-2020 which was received by this Commission on 11-11-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Birkur Mandal, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 26-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 01-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 01-07-2021 with prior intimation to the concerned parties. The complainant responded and stated that the PIO has furnished the information. The PIO / Sri. Ganesh, Deputy Tahsildar, Birkoor Mandal, Kamareddy District did not respond, but filed the copies of the information furnished to the complainant.

Heard the PIO and perused the material paper available on record and observed that the complainant through his 6(1) application dated: 26-08-2020 seeking information and the PIO has filed the information vide letter No: B/734/2020 dated: 26-11-2020.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005 and for not attending the Commission hearing. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
