## **Order**

Sri S. Venkata Swamy, Mahabubnagar District has filed a Complaint dated: 09-09-2020 which was received by this Commission on 19-11-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Chintakunta Mandal, Mahabubnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: Nil before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

తమరితో చేయు మనవి ఏమనగా తెలంగాణ ప్రభుత్వము చేపాట్టిన భూ రికార్డులకు సంబంధించి అవ్యక్తం అయినదిపండి భూములను గుర్తించి అసలైన పట్టాదారులను గుర్తించినారు. అందులో బాగంగానే వడ్డెమాన్ గ్రామానికి సంబంధించి పాత్రు 2(బి)గుర్తించిన ఖాతనెంబరులు వాటికి సంబంధించి సర్వే నెంబరులు మరియు పట్టాదారుల పేర్లు. యొక్క బిరాక్స్ కాపలు కిచ్చగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint may be taken on file and Notices issued to both the parties for hearing on 12-08-2021 at 10.30 A.M.

The case is called on 12-08-2021. The complainant is present and stated that the PIO has not furnished the information. The PIO / Sri E. Anjaneyulu, Deputy Tahsildar, Chintakunta Mandal, Mahabubnagar District stating that the information was furnished to the complainant on 28-09-2020 by hand and filed the copy of the same along with the postal acknowledgement of the complainant before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information once again to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
