Order

Smt. Rukhiya Begum, Nirmal District has filed 2nd appeal dated: 16-11-2020 which was received by this Commission on 20-11-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District and 1st Appellate Authority / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- * మి కార్పొరేషన్ ద్వారా తేదీ: 15-05-2020 తేదీన కొర్రాపల్లి, కంకర్ లో కోనేటి నేలసర్ది, లకు జంబి చేసిన భవన నిర్మాణ అనుమతికి ఆయన సమర్పించిన డిజిన్ బుక్ చిత్రావళి, అయి బస్తావేసల మరయు భవన నిర్మాణ అనుమతి పత్రాలను పునీకరించి ఇవ్వగలరు.
- * అట్టి స్థాన పరిశీలన చేసిన TPG & TPO రిపోర్టులను పునీకరించి ఇవ్వగలరు.
- * అట్టి భవన నిర్మాణ అనుమతికి సంబంధించిన వస్త్రినా కార్డు తేసులు ఉన్నట్లైతే వివరాలు ఇవ్వగలరు... తమ బకవళి కార్డుకేసు ఉంటే మీ యొక్క హైకార్డు స్ట్రయి సలహా వ్రాత పునీకరింపాలి కానీ. మాఖ్యంగా త్రిసుకునామా...? వివరాలు తెలిపగలరు.
- * అట్టి భవన నిర్మాణ అనుమతికి సమర్పించిన మార్టింగు వేదా అండర్ టేకింగ్ బస్తావేసల సమర్పించాలి? సమర్పించినట్లైతే అట్టి చిత్రావేసల పునీకరించి ఇవ్వగలరు...

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 12-10-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The representative of the appellant is present and stated that the PIO has not furnished the information. The PIO / Smt. A. Sumalatha, Town Planning Officer, O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District is present and stated that the appellant is seeking 3rd party information, vide letter No: G1/RTI/15/2020 dated: 08-06-2020 and letter No: G1/RTI/213/2020 dated: 22-06-2020 notices were issued to the 3rd party under section 11 of RTI Act 2005 to give their concern whether to furnish the required information or not and the 3rd party has informed that since it is their personal information and should not be disclosed any other person. The PIO vide letter No: G1/RTI/60/2020 dated: 02-12-2020 informed the same to the appellant and filed the copies of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 30-05-2020 seeking information on 4 points.

The Commission directs the PIO to furnish the permission copy to the appellant and for the remaining information, the PIO is directed to transfer the application u/s 6(3) of RTI Act 2005 to the PIO / O/o the Tahsildar, Nirmal Mandal, Nirmal District with a request to furnish the information (keeping in view of Section 8, 9, 10 & 11 of RTI Act 2005) immediately on the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
