## Order

Sri. E. Karunakar, Hyderabad has filed 2<sup>nd</sup> appeal dated: 05-11-2020 which was received by this Commission on 20-11-2020 for not getting the information sought by him from the PIO / O/o the Commissioner and Director, of School Education, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Commissioner and Director, of School Education, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Please furnish the details of department and scheme wise cadre strength of Assistant Directors and no. of posts are filled from 02.06.2014
2. I request you to inform the required Educational Qualifications and Departmental tests to be passed for promotion to the post of Assistant Director
3. Please inform Eligibility criteria for promotion to the post of Asst. Directors
4. Inform the feeder category posts to the post of Asst. Directors
5. Extract copy of Asst. Directors Roster points Register
6. Whether any exemption from passing the Departmental tests for promotion to the post of Asst. Directors, if so, furnish the copy of exemption orders.
7. Plz furnish the latest Seniority list and year wise approved panel list of Superintendent and equaling cadre for promotion to the post of Asst. Directors from 02.06.2014 to till date.
8. Plz furnish the DPC notes of Asst. Directors, along with minutes of DPC meeting from 02.06.2014 to till day.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 05-10-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 30-07-2021 at 11.00 A.M.

In view of the Covid -19 Pandemic, the cases are heard over phone on 30-07-2021 with prior intimation to the concerned parties. The appellant responded and stated that the PIO has not furnished the information. The PIO / Sri. Parmeshwar, Assistant Director, O/o the Commissioner & Director, School Education, Telangana, Hyderabad responded and stated that vide letter Rc. No: 113/Ser-II/2020 dated: 22-09-2020 the appellant was requested to visit their office for perusal of records on 29-09-2020. Instead of the appellant unknown 2 persons appeared and refused to show their identity proof, hence no information was furnished to the appellant.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 28-08-2020 seeking information on 8 points. The PIO submitted that vide letter Rc. No: 132/Ser-II/2020 dated: 27-07-2021 the information was furnished to the appellant, but failed to submit the postal evidence before the Commission.

The Commission directs the PIO to furnish the information to the appellant once again within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
