## Order

Sri Kaleem Ahmed, Nirmal District has filed 2<sup>nd</sup> appeal dated: 16-11-2020 which was received by this Commission on 21-11-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-09-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 24-09-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal may be taken on file and Notices issued to both the parties for hearing on 02-09-2021 at 10.30 A.M.

The case is called on 02-09-2021. The appellant is present and stated that the PIO has not furnished information. The PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District is absent.

Heard the appellant and perused the material paper available on record and observed that the appellant filed 6(1) application dated: 24-09-2019 seeking information on 3 points.

The Commission took a serious view and directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri Damara Vinay, Assistant Executive Engineer, O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act and for not appearing for the hearing held on 02-09-2021. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the present PIO to furnish the complete information to the appellant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
