Order

Sri Ravinder, Nizamabad District has filed a Complaint dated: 17-08-2021 which was received by this Commission on 23-08-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nizamabad Municipal Corporation, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 16-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Furnish u/s RTI-ACT. 2005 only APIO., PIO and AA should collect the Request application not in inward section of the concerned Department. supply Xerox copy/copies of the Act. with attestation.

and more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri Mohammad Khadeer Pasha, Superintendent, O/o the Nizamabad Municipal Corporation, Nizamabad District is present and filed his affidavit stating that a reply was given to the appellant vide letter No: PIO/5637/2021 dated: 07-09-2021 and filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The Commission is not satisfied with the reply of the PIO.

The Commission directs the PIO to give point wise specific reply to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

Issue **Show Cause Notice** to the PIO / Sri M. Ravi Babu, Deputy Municipal Commissioner, O/o the Nizambad Municipal Corporation, Nizambad District for furnishing irrelevant information to the appellant. The action on the **Show Cause Notice** will be dealt separately.
