Order

Sri R. Dharma Naik, Hyderabad has filed 2nd appeal dated: 22-08-2021 which was received by this Commission on 23-08-2021 for not getting the information sought by him from the PIO / O/o the Tahsildr, Marriguda Mandal, Nalgonda District and 1st Appellate Authority / O/o the Tahsildr, Marriguda Mandal, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 05-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

స్టాంపు చేసినట్లుగానే స్టాంపు రుణాలు జారీ కావాలి. RI ఇచ్చిన రుణం జారీ
కావాలి ఇప్పటికే మీకు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 07-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 07-07-2022 at 10.30 A.M.

The case is called on 07-07-2022. The appellant is absent. The PIO / Sri J. Tharaka Raman, Deputy Tahsildar, Marriguda Mandal, Nalgonda District is present and filed his affidavit stating that part information was furnished to the appellant vide letter No: 512/2021 dated: 20-09-2021 and complete information is brought to the Commission and is ready to be furnished to the appellant. The PIO filed copy of the letter dated: 20-09-2021 before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the complete information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
