## **Order**

Sri M. Ravindran, Kerala has filed a Complaint dated: 19-01-2022 which was received by this Commission on 24-01-2022 for not getting the information sought by him from the PIO / O/o the Managing Director, Telangana State Road Transport Corporation, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- (i) Respected Supreme Court of India by Ms. P. Vaishnavi (of CHIDEDU Village, Manchal Mandal, Telungana), and,
- (ii) Letter forwarded to Managing Director of Telungana State Road Transport Corporation by Respected Supreme Court of India, and
- (iii) Managing Director's compliance letter.

The PIO / O/o the Managing Director, Telangana State Road Transport Corporation, Hyderabad vide Lr. No. E1/RTI Act (21)/2021-GHZ dated. 24-11-2021 transferred an application U/s 6(3) of the RTI Act to O/o the Depot Manager, Ibrahimpattanam Depot, Ranga Reddy District with a request to furnished the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The complainant is absent, but filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri B. Ashok Raju, Depot Manager, Ibrahimpatnam Depot and Mandal, Ranga Reddy District and the PIO / Sri N. Ranjith Kumar, Personal Officer, O/o the Managing Director, TSRTC, Bus Bhavan, Musheerabad, Hyderabad are present and filed affidavit stating that the complainant is seeking information based on news published on social media platform across the state and nation and they have not received any representation or complaint from the concerned and on oral instructions the operation of bus from Ibrahimpatnam to Chidedu village has been provided from 03-11-2021, hence no information was furnished to the complainant.

Heard the PIOs and perused the material papers available on record.

Keeping in view of the submissions made by the PIO, the Commission directs the PIO to give specific reply to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
