Order

Sri Ch. Vidyasagar, Nalgonda District has filed 2nd appeal dated: 23-12-2020 which was received by this Commission on 23-12-2020 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Nalgonda Depot, Nalgonda District and 1st Appellate Authority / O/o the Depot Manager, TSRTC, Nalgonda Depot, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-08-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

రూ. 4750 కి కమిషన్ వల్ల వచ్చిన 4398 రూ. మార్పు చేసినారు. రూ. 360 -
DUE వున్నది అది పూర్తి చేయమని కోరారు.
4. Dt. 05/01/2015 వల్ల ఇంటిమండ్ల వ్యవస్థను : 1941 + 13203 - ప్రైంట్లు
అకౌంట్ లో ప్రైంట్లు చేయమని కోరారు. సమాధానము తెల్పకపోయి,
Dt. 11/01/14 నాడు కమిషన్ కోర్టు. ప్రైంట్లు అడ్డవిగా ఉండవలసిందిగా కోరారు.
చేసి 1941 అడ్డవిగా ఉండవలసిందిగా కోరారు. (6) మాసము దాకా పంపించినట్లు
పంపించినట్లుగా కోరారు. అధికారి ద్వారా అడ్డవి ప్రైంట్లు పంపించినట్లు
చరవాస్తు దఫాము రూ. 1.00. ఇంటిమండ్ల వ్యవస్థ అర్హులు కోర్టు పే నామము రూ. 1000. నగదు/ అమందు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri G. Ram Mohan Reddy, Depot Manager, TSRTC Nalgonda Depot, Nalgonda District is present and filed his affidavit stating that reply was given to the appellant vide letter No: Dy.Sup/510(2020)-NLG dated: 21-10-2020 and filed copies of the information furnished before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has not furnished the complete information, the PIO furnished copies of the information to the appellant before the Commission.

Since the information is furnished, the appeal is closed.
