Order

Sri Ubbani Raju, Nalgonda District has filed 2nd appeal dated: 16-09-2021 which was received by this Commission on 16-09-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Haliya Mandal, Nalgonda District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Miryalguda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 07-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. దూరకాల్లుల నిర్వహణ కోసం తెలంగాణ రాష్ట్ర ప్రభుత్వం తీసుకొచ్చిన " ధరణి పోర్టల్" నిర్వహణకు హాళియ తహసీల్దార్ (MRO) కు, infrastructure portal నిర్వహణ కోసం రాష్ట్ర ప్రభుత్వం మంజూరు చేసిన " 10 లక్షల రూపాయలు వి విదంగా ఖర్చు చేశారు,

ఈ ఆఫీస్ లో dharani registration కొరకు పర్మిషన్, ఇతర పరికరాలు కొనుగోలు (కంప్యూటర్, స్కానర్, ప్రింటర్, థంబ్, ఇరిస్) కొనుగోలుకు అయిన ఖర్చు మరియు దానికి సంబంధించిన బిల్లుల వివరాలు ఇవ్వగలరు,

10 లక్షల రూపాయల్లో తహసీల్దార్ (MRO) త్రిజర్ ద్వారా ఎన్ని బిల్లులు డ్రా చేశారు, త్రిజర్ బిల్లుల వివరాలు మరియు మిగిలిన నగదు వివరాలు ఇవ్వగలరు..

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 12-07-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 07-07-2022 at 12:00 P.M.

The case is called on 07-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri SK. Javeed, Deputy Tahsildar, Haliya Mandal, Nalgonda District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: B/401/2021 dated: 30-06-2022 and filed copy of the same before the Commission.

Sri Mohd. Hasimullah Sharif, Deputy Tahsildar representing the First Appellate Authority / Sri B. Rohith Singh, Revenue Divisional Officer, Miryalguda Division, Nalgonda District is present, but did not file copies or correspondence communicated before the Commission.

Heard both the parties and perused the material papers available on records and observed that the present PIO and the then PIO have failed to furnish the information within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005.

Issue **Show Cause Notice** to the present PIO / S.K. Javeed, Deputy Tahsildar, Haliya Mandal, Nalgonda District and the then PIO / Sri Yashwanth Raj, Deputy Tahsildar, Haliya Mandal, Nalgonda District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
