## Order

Sri Md. Khadeer Ahmed, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 21-09-2021 which was received by this Commission on 21-09-2021 for not getting the information sought by him from the PIO / O/o the District Collector, Nalgonda Collectorate, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-01-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) నల్లగొండ జిల్లా లోని గుత్తంపేడు, కనగల్, కొండ మల్లేపల్లి, దేవరకొండ, చందంపేట, నేరేడుగొమ్ము మండలాల్లో ఎవ్వరి కట్టాలో లేని వ్యవసాయానికి పనికివచ్చే ప్రభుత్వ భూమి ఎంత ఉన్నది. అది పూర్తిగా ప్రభుత్వ స్వదనంలో ఉన్నదా.
- 2) గుత్తంపేడు, కనగల్, కొండ మల్లేపల్లి, దేవరకొండ, చందంపేట, నేరేడుగొమ్ము మండలాల్లో గ్రామాల వారీగా సర్వే నెంబర్ ల వారీగా వ్యవసాయానికి పనికి వచ్చే ఎవ్వరి అదనంలో (కట్టా) లేని ప్రభుత్వ భూమి సమాచారాన్ని ఈక్రింద తెలిపిన విధంగా అందించగలరు.

- 3) భూమి లేని మాజీ సైనిక ఉద్యోగులకు ప్రభుత్వం కేటాయించే వ్యవసాయ భూమికి సంబంధించిన విడి విధానాలు తెలుపగలరు?
- 4) భూమి లేని మాజీ సైనిక ఉద్యోగులకు ప్రభుత్వం ఎంతమేరకు వ్యవసాయ భూమిని కేటాయిస్తున్నది. దానికి జతచేయవలసిన documents వివరములు తెలుపగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 24-03-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. Sri D. Sunil Kumar, Senior Assistant is present on behalf of the PIO / Sri K.M.V. Jagannadha Rao, District Revenue Officer (FAC), O/o the District Collector, Nalgonda District and filed his affidavit stating that vide letter No: A5/e-973/2021 dated: 06-02-2021 the application was transferred to the concerned Tahsildars with a request to furnish the information to the appellant and on receipt of the Commission Notice dated: 29-07-2022 another letter was sent the above Tahsildars to furnish the information to the appellant. The representative of the PIO filed copies of the letters along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The representative of the PIO stated that part information is being furnished by the PIO's.

The Commission directs the PIO to furnish the balance information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
