Order

Sri Mohd Ather Nawab, Hyderabad has filed a Complaint dated: 23-09-2021 which was received by this Commission on 24-09-2021 for not getting the information sought by him from the PIO / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 16-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

① Please provide Duly Attested copy of Action Take Report By your office, on this Application which Submitted on The Dt:- 09/08/2021, (Copy Enclosed of Above Application)

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The complainant is absent. Sri D. Sunil Kumar, Senior Assistant is present on behalf of the PIO / Sri A. Bhaskar Rao, District Revenue Officer (FAC), O/o the District Collector, Nalgonda District and filed his affidavit stating that vide letter No: A5/5169/2021 dated: 24-07-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Revenue Divisional Officer, Nalgonda Division & District with a request to furnish the information to the appellant and on receipt of the Commission Notice dated: 29-07-2022 another letter was sent on the PIO to furnish the information to the appellant. The representative of the PIO filed copies of the letters along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The representative of the PIO stated that part information is being furnished by the PIO's.

The Commission directs the PIO / O/o the Revenue Divisional Officer, Nalgonda Division & District to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
