## **Order**

Sri Syed Khadeer, Mahabubnagar District has filed 2<sup>nd</sup> appeal dated: 27-01-2022 which was received by this Commission on 27-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Rajapur Mandal, Mahabubnagar District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

**విషయము : నమాచార హక్కు చట్టం 2005 ప్రకారం రాజాపూర్ మండలం, అగ్రహారం పొట్లపల్లి గ్రామంన సర్వే నెంబర్ 18,19,20,30 లలో కాళీ నడకబాట (పానది) క్లియర్ చేయుటకు తేదీ: 16-12-2019 దరఖాస్తు పెట్టినాము. మరియు ఇట్టి దరఖాస్తు ఇంకా పెండింగ్ లో ఉన్నది. ఇదే సర్వే నెంబర్ 18,19,20,30 లలో అనేక సార్లు అసగా తేదీ: 17-12-2019, & 05-11-2021 సర్వే చేసినారు కానీ కాళీ బాట (పానది) క్లియర్ చేయలేదు అందుకు కు గల కారణాలు తెలియజేయగలరు**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 22-12-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is present and filed his affidavit stating that the PIO has furnished incomplete information. The PIO / Sri M. Bharath Kumar, Deputy Tahsildar, Rajapur Mandal, Mahabubnagar District is present and filed his affidavit stating that the information was furnished to the appellant vide letter no: B/02/2022 dated: 04-01-2022 and filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has not furnished the copy of map as per Naksha Patta.

The Commission directs the PIO to furnish the information or give specific reply to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
