## **Order**

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2<sup>nd</sup> appeal dated: 17-01-2022 which was received by this Commission on 27-01-2022 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Komarambheem Asifabad District and 1<sup>st</sup> Appellate Authority / O/o the District Educational Officer, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 11-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

6. నేను మీ కార్యాలయము లో 15-10-2019 రోజున SPECIAL INCENTIVE AWARD గురించి సమర్పించిన ప్రాతినిధ్యం పై మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Public Service Bill-2006, Note File with Rule Position తో పాటు ఇవ్వగలరు. (Copy enclosed)
7. నేను మీ కార్యాలయము లో 15-10-2019 రోజున HEAD MASTER, GHS NO 5 గురించి సమర్పించిన ప్రాతినిధ్యం పై మీరు చేపట్టిన చర్యల ప్రతులను District Office Manual Rules, Public Service Bill-2006, Note File with Rule Position తో పాటు ఇవ్వగలరు. (Copy enclosed)

and more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 19-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is absent. The APIO / Sri M. Varaprasad, Senior Assistant is present and filed affidavit of the PIO / Sri E. Gamanial, Assistant Director, District Educational Officer, Komaram Bheem Asifabad District stating that vide letter Rc. No: B7/216/RTI/2021 dated: 21-10-2021 the application for forwarded to the B-Section of the same office with a request to furnish the information to the appellant and point wise information was furnished vide letter Rc. No: B1/RTI/216/2022 dated: 24-08-2022 and filed copy of the covering letter and the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
