## **Order**

Sri V. Ravinder Reddy, Hyderabad has filed a Complaint dated: Nil which was received by this Commission on 29-09-2021 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 23-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) గాంధీ నంబర్ 46 ప్రైవేట్ స్కూల్ లో ఎడ్యుకేషన్ ఫీ వసూలు చేసినట్లు నిరూపించుకోవాలి.
  - 2) Academic year 2020-2021 కు ఎడ్యుకేషన్ ఫీ వసూలు చేసినట్లు నిరూపించుకోవాలి.
  - 3) Private school లో total fee collection receipt లో 5 లక్షల 60 వేల రూపాయల వరకు ఎడ్యుకేషన్ ఫీ వసూలు చేసినట్లు నిరూపించుకోవాలి.
  - 4) గాంధీ నంబర్ 46 Academic year 2021-2022 కు ఎడ్యుకేషన్ ఫీ వసూలు చేసినట్లు నిరూపించుకోవాలి.
  - 5) Academic year 2020-2021 కు ఎడ్యుకేషన్ ఫీ వసూలు చేసినట్లు నిరూపించుకోవాలి.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri G. Parmesham, Assistant Director, O/o the Commissioner & Director of School Education, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 514/RTI/2021 dated: 27-07-2021 and filed copy of the reply given along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The complainant stated that the PIO has not furnished any information, but rejected stating the information sought is not as per section 2(j) & (f) of RTI Act 2005. The Commission upholds the reply of the PIO.

In view of the above, the complaint is closed.
