## **Order**

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2<sup>nd</sup> appeal dated: 13-01-2022 which was received by this Commission on 27-01-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Komarambheem Asifabad District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 12-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 30-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 10.30 A.M.

The case is called on 18-08-2022. The appellant is absent. The APIO / Sri B. Ramlal, Deputy Tahsildar is present on behalf of the PIO / Sri Kadam Suresh, District Revenue Officer, O/o the District Collector, Komaram Bheem Asifabad District and filed his affidavit stating that the information is furnished to the appellant vide letter No: A2/RTI-01/2021 dated: 28-10-2021 and filed copies of the information furnished along with the acknowledgement of the appellant before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to inform the present status of the enquiry to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
