## Order

Sri Syed Azmat Ali, Jagitial District has filed 2<sup>nd</sup> appeal dated: 24-09-2021 which was received by this Commission on 01-10-2021 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o the District Panchayat Officer, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

రాష్ట్ర సమాచార కమిషన్ లోని నాఫిర్మాడు నెం. 10790/SIC-SK/2018 పై తేదీ 8-4-2021న విచారణ కొండెను. నేను ఆనాటి విచారణకు హాజరుకాలేదు. తమరి కార్యాలయ సమాచార అధికారులు హాజరై విచారణ సమయములో రాష్ట్ర సమాచార కమిషన్ కి గారిల్లా నాకు గతములోనే కలిగిన సమాచారం పంపినట్లు 44 పేజీల సమాచారం కవర్ లో తప్పక నెం. A1/2978/2017/PA తేదీ 3-10-2017న పంపినట్లు పోస్టు ఆఫీస్ రసీదులతో సహా చూపించినారు. కావున రాష్ట్ర సమాచార కమిషన్ కి గారికి విచారణ కొరకు తేదీ 8-4-2021న నాకు సమాచారం పంపినట్లు చూపించిన అన్ని ఆధారాలు తనిఖీ చేసి నా చేరునామాకు పంపిన పోస్టు ఆఫీస్ రసీదు మరియు నాకు పోస్టు ఆఫీస్ రసీదులను Acknowledgement తో సహా ప్రోవ్ చేయగలరు. కుసుము రూ. 10/- తా. సగరు/డిమాండ్ (రాష్ట్ర/బ్యాంకర్స్ చెక్కు/ఇండియన్ పోస్టు ఆర్డరు) గలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 19-08-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 12.00 P.M.

The case is called on 26-09-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri Md. Fareeduddin, Administrative Officer, O/o the District Panchayat Office, Karimnagar District is present and filed his affidavit stating that the information was furnished to the appellant on many occasions, but the appellant is repeatedly seeking the same information again and again.

Heard both the parties and perused the material papers available on record. The PIO submitted that the similar cases was heard by the Commission vide appeal No: 27015/CIC/2017 dated: 30-05-2018, 10790/SIC-SK/2018 dated: 08-04-2021 and 12543/SIC-SK/2021 dated: 24-06-2022 and the same were closed after furnishing the information.

The Commission directs the PIO to give a specific reply informing the factual position to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
