Order

Sri P. Dasaratham, Ranga Reddy District has filed 2nd appeal dated: 28-09-2021 which was received by this Commission on 01-10-2021 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 18-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The complainant is absent. The PIO / Sri G. Parmesham, Assistant Director, O/o the Commissioner & Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 582/RTI/2021 dated: 13-09-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the District Educational Officer, Sanga Reddy District with a request to furnish the information to the complainant. The PIO filed copy of the letter along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO / O/o the District Educational Officer, Sanga Reddy District to furnish the information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
