## **Order**

Sri B. Rama Rao, Karimnagar District has filed a Complaint dated: 30-09-2021 which was received by this Commission on 04-10-2021 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 15-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) LA NO AS/CON/2020 - date 5/10/2020; బాధ్యత గల వ్యక్తి

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The complainant is absent. The APIO / Sri K. Kranthi Kumar, Junior Assistant, O/o the District Panchayat Office, Karimnagar District is present and filed his affidavit stating that the application was forwarded to the PIO / O/o the Divisional Panchayat Officer, Karimnagar District to look into the matter and furnish the information to the complainant and accordingly a reply was given by the PIO vide letter No: DKPO/11/2021-Pa dated: 30-09-2021 and an order was also issued to the Gram Panchayat Secretary, Manakondur Village and the Divisional Panchayat Officer, Karimnagar District not to make any changes until they submit the legal hire details to their office. The APIO filed copy of the same before the Commission.

Heard the APIO and perused the material papers available on record. The APIO further submitted that the copy of the report was furnished to the brother of the complainant and acknowledgement was also taken from him.

The Commission is of the view that the APIO has informed the factual position to the complainant.

In view of the above, the complaint is closed.
