Sri M. Venkat Reddy, Hyderabad has filed a Complaint dated: 27-09-2021 which was received by this Commission on 05-10-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Nidamanoor Mandal, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Private Persons and submitting before higher officials.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri M. A. Rasheed, Deputy Tahsildar, Nidamanoor Mandal, Nalgonda District is present and filed his affidavit stating that reply was given to the complainant vide letter No: A/264/2021 dated: 18-09-2021 requesting to inform in which year the changes were made and vide letter No: A/362/2021 dated: 26-10-2021 the complainant was informed that the information sought is not available. The PIO filed copies of the replies before the Commission.

Heard both the parties and perused the material papers available on record. The PIO submitted that the available information was furnished to the complainant. The complainant stated that the PIO has furnished part information.

The Commission directs the PIO to allow the complainant for verification of records on a mutually fixed date and time by giving a prior intimation to the complainant and furnish the required information to the complainant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
