Order

Sri D. Ashok Reddy, Nalgonda District has filed 2nd appeal dated: 30-09-2021 which was received by this Commission on 07-10-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Madgulapally Mandal, Nalgonda District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Miryalguda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-05-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 02-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri N. Shiva Shankar, Deputy Tahsildar, Madgulapalli Mandal, Nalgonda District is present and filed his affidavit stating that reply was given to the appellant vide letter No: B/556/2022 dated: 08-08-2022 informing that the information is not specific and is in questionnaire form, hence could not be furnished. The PIO filed copy of the reply before the Commission.

Sri Mohd. Hajimulla Sharif, Deputy Tahsildar is present on behalf of the First Appellate Authority / Sri B. Rohit Singh, Revenue Divisional Officer, Miryalguda Division, Nalgonda District.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO is wantonly not furnishing the information.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information or give point wise reply to the appellant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO / Sri N. Shiva Shankar, Deputy Tahsildar, Madgulapalli Mandal, Nalgonda District and the then PIO / Smt. K. Sangamithra, Deputy Tahsildar, Madgulapalli Mandal, Nalgonda District for not furnishing the information to the appellant with the stipulated period of 30 days. The action on the **Show Cause Notice** will be dealt separately.
