Order

Sri Vibhuti Brahmaiah, Nagarkurnool District has filed 2nd appeal dated: 08-10-2021 which was received by this Commission on 08-10-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Gundlapally (Dindi) Mandal, Nalgonda District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Devarakonda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 3) స.నం. 31, 41 9 42 కింద కింద, కింద కింద (కింద)
నంబరు కింద కింద కింద కింద.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 06-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri R. Gopa Raju, Mandal Revenue Inspector, Gundlapally Mandal, Nalgonda District is present and filed his affidavit requesting to give time to furnish the information to the appellant.

Sri Md. Sirajoddin, Senior Assistant is present and filed affidavit of the First Appellate Authority / Sri K. Gopiram, Revenue Divisional Officer, Devarkonda Division, Nalgonda District stating that vide letter No: C/837/2021 dated: 09-08-2021 the appellant and the PIO were called for hearing on 17-08-2021 and an order was passed on 21-08-2021 to furnish the information to the appellant.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri K. Narsimaha Rao, Deputy Tahsildar, Gundlapally (Dindi) Mandal, Nalgonda District for not furnishing the information to the appellant with the stipulated period of 30 days as per section 7(1) of the RTI Act 2005 and for not furnishing the information to the appellant even after direction given by the First Appellate Authority on 21-08-2021. The action on the **Show Cause Notice** will be dealt separately.
