Order

Sri K. Sai Manohar, Nellore District has filed a Complaint dated: 22-09-2021 which was received by this Commission on 08-10-2021 for not getting the information sought by him from the PIO / O/o the Roads and Building Department, Deputy Engineer In Chief (R&B), (Admin), Erramanzil, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 17-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

I, K Sai Manohar residing in the said address requesting to provide certain information relating to Sri Orugunta Sridhar, Deputy Executive Engineer (R&B) Department (Epm.ID:2586989) under Right to Information Act 2005 on the following points.

1. Date of entry into service by Sri O.Sridhar (Emp.ID:2586989)
2. Date of promotion to the next cadre.
3. Kinds of leave availed by Sri O. Sridhar during the service With dates and Number of days category wise from the date of joining.
4. Places of working of the individual date wise.
5. Annual Property Statements submitted by Sri O.Sridhar year wise.

and few more points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 23-06-2022 at 12:00 P.M.

The case is called on 01-09-2022. The complainant is absent. The PIO / O/o the Executive Engineer, R&B Department, Erramanzil, Hyderabad is also absent.

Perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) to the complainant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
