## Order

Sri Kandela Prakash, Nirmal District has filed a Complaint dated: 12-10-2021 which was received by this Commission on 14-10-2021 for not getting the information sought by him from the PIO / O/o the Special Deputy Collector, SRSP, Yellamagutta, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 16-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 19-05-2022 at 10.30 A.M.

The case is called on 19-08-2022. The complainant is absent. Smt. T. Rajani Kumari, Special Deputy Tahsildar, O/o the Special Deputy Collector, Land Acquisition and R&R, Nizambad District is present and filed her affidavit stating that reply was given to the complainant vide letter No: A/44/2021 dated: 09-11-2021 informing that the information sought is in questionnaire, hence the information could not be furnished. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the complaint within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
