Smt. S. Suguna, Hyderabad has filed 2nd appeal dated: 20-10-2021 which was received by this Commission on 20-10-2021 for not getting the information sought by her from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1) DSC-2002 పంపిణీ బాధ్యతల జాబితా లో ప్రయోజనం బడిన -
Language Pandith (Hindi: Pandith) H.P-II. జాబితా కాపీని -
(కాపీ, రికార్డు) పంపించుటకు Certifi copy పట్టించుట.
కరణం: రికార్డులు డి.ఎం.ఆర్. కేంద్రం వద్ద ఉన్నాయి కానీ ప్రయోజనం బడిన
ప్రయోజనం - 2005 పంపించుటకు రికార్డు పట్టించుట.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing her 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The appellant is absent. The PIO / Sri G. Parmeshwar, Assistant Director, O/o the Commissioner and Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 547/RTI/2021 dated: 18-08-2021 and vide letter No: 596/RTI/2021 dated: 24-09-2021 the application was transferred u/s 6(3) of the RTI Act to the PIO / O/o the District Educational Officer, Ranga Reddy District with a request to furnish the information to the appellant. The PIO filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO / O/o the District Educational Officer, Ranga Reddy District to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
