Order

Sri Mohd Ather Nawab, Hyderabad has filed a Complaint dated: 19-10-2021 which was received by this Commission on 23-10-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Narketpalli Mandal, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 15-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

① please provide duly Attested copy of Action Taken Report, By your office on this Application, Dt:- 02/09/21,
(copy enclosed of Above Application 02/09/21)

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The complainant is absent. The PIO / Sri K. Murali Mohan, Deputy Tahsildar, Narketpally Mandal, Nalgonda District is present and filed his affidavit stating that vide letter No: B/804/2021 dated: 03-02-2022 the complainant was informed that the application has been forwarded to the Mandal Girdawar to enquire into the contents and submit the report for taking necessary action. The PIO filed copy of the same along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that even on the present date of hearing the PIO is submitting the same that the matter is still under process. The Commission cannot accept the submission made by the PIO.

The Commission directs the PIO to inform the present status and furnish the information to the complainant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri K. Murali Mohan, Deputy Tahsildar, Narketpally Mandal, Nalgonda District and the Deemed PIO / Mrs. Manga, Mandal Girdawar, Narketpally Mandal, Nalgonda District for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7 (1) of the RTI Act 2005 and for still giving the same reply before the Commission that the matter is pending. The action on the **Show Cause Notice** will be dealt separately.
