Order

Sri Mohd Ather Nawab, Hyderabad has filed a Complaint dated: 20-10-2021 which was received by this Commission on 23-10-2021 for not getting the information sought by him from the PIO / O/o the Chief Commissioner of Land Administration, Nampally Station Road, Nampally, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 15-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

① Please provide duly attested copy of Action Taken Report, By your office on this Application dt:- 02/09/21, (copy enclosed of. Above Application = 02/09/2021)

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The appellant is absent. The APIO / Sri S.V. Sumitra, Superintendent Grade – I is present and filed affidavit of the PIO / Smt. K. Durga, Addl. Asst. Commissioner (Budget), O/o the CCLA, Nampally, Hyderabad stating that vide letter Ref. No: RTI-I(1)/450/2021 dated: 27-09-2021 the application was forwarded u/s 6(3) of the RTI Act 2005 to the PIO / District Collector, Nalgonda District with a request to furnish the information to the appellant and filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO / Deputy Tahsildar, Narketpally Mandal, Nalgonda District to inform the present status and furnish the information to the complainant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
