Order

Sri P. Rama Prasad, Visakhapatnam has filed 2nd appeal dated: 20-10-2021 which was received by this Commission on 25-10-2021 for not getting the information sought by him from the PIO / Administrative Officer, O/o the Hon'ble Metropolitan Session Judge Court, Nampally, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 07-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

03-1-2020 తెదీనాటి, ఉదయం 11 - 12 గం.ల నడుమ, Nampally Criminal Court ప్రవేశద్వారముల వద్ద ఏర్పరచిన C.C.T.V. recordings ప్రతులను, R.T.I. Act, Section 2 (j) (2) ప్రకారం, ధృవీకరించి యివ్వవలసిందిగా కోరుచున్నాను. .

The PIO Lr. Dis. No. 1129/MSJ/RTI/Hyd/2020, dated. 24-02-2020 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 26-09-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is absent. The PIO / Sri R. Ramu, Chief Administrative Officer, O/o the Hon'ble Metropolitan Session Judge Court, Nampally, Hyderabad is present and filed his affidavit stating that the appellant filed 6(1) application dated: 07-02-2020 before the PIO / O/o the SHO, Nampally Police Station, Hyderabad and the SHO transferred the application u/s 6(3) of the RTI Act 2005 to the PIO / Administrative Officer, Metropolitan Session Judge Court, Nampally, Hyderabad, accordingly reply was given to the appellant vide letter Dis. No: 1129/MSJ/RTI/Hyd/2020 dated: 24-02-2020 informing that the information sought cannot be provided as it is under the purview of the Hon'ble High Court. The PIO further submitted there CCTV footage will be deleted automatically after 30 days. The PIO filed copies of the same before the Commission.

Sri G. Naresh representative of Sri A. Kranthi Kumar Reddy, Advocate and Standing Counsel for the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad is present and filed his affidavit stating that an order was passed vide appeal No: 19 of 2020 dated: 21-11-2020 informing that neither SAPIO nor the Appellate Authority are authorized to share the said CCTV footage as per the directions of the Hon'ble Supreme Court Order in *Pradyuman Bisht vs Union of India* dated: 28-02-2017 unless permitted by the Hon'ble High Court. The representative of the PIO filed copies of the same before the Commission.

Heard the PIO and perused the material papers available on record. The Commission upholds the reply of the PIO and the First Appellate Authority.

In view of the above, the appeal is closed.
