Order

Sri P. Rama Prasad, Vishakapatnam has filed 2nd appeal dated: 20-10-2021 which was received by this Commission on 25-10-2021 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 11-11-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Respected Sir/Madam,

పై సూచికలో పేర్కొనబడిన ఫిర్యాదుపత్రం దరిమిలా, తమ కార్యాలయం నుండి గైకొనబడిన చర్యల సమాచారంను తెలియపర్చు పత్రముల ప్రతులను, R.T.I. Act, Section 2 (j) (ii) ప్రకారం, ధృవీకరించి యివ్వవలసిందిగా కోరుచున్నాను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 31-12-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is absent. Sri G. Naresh representative of Sri A. Kranthi Kumar Reddy, Advocate and Standing Counsel for the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter ROC No: 294/PIO/JUDL/2020 dated: 09-12-2020 and on filing 1st appeal dated: 31-12-2020 and Order was passed vide Appeal No: 16 of 2021 dated: 25-02-2021. The representative of the PIO filed copies of the same before the Commission.

Perused the material papers available on record. The Commission is of the view that the PIO has informed the factual position of the application dated: 09-11-2012.

Upholding the reply of the PIO, the appeal is closed.
