## Order

Smt. Korra Sona, Nalgonda District has filed a Complaint dated: 25-10-2021 which was received by this Commission on 27-10-2021 for not getting the information sought by her from the PIO / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 30-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application annexed.

నాకు ఇబ్బంది మంజూరు అయినట్లు తెలిసా? వస్తే  
దే ఇంటి నిర్మాణమునకు ధరభాస్త ప్రభుత్వం ను  
వచ్చును ఇస్తా? నాకుండు చాలా వలూ R.T.  
కొండా నిర్మాణము ఇచ్చింపగలరాను.

Stating that the PIO has not furnished the required information even after 30 days of filing her application, she preferred this Complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The complainant is absent. Sri D. Sunil Kumar, Senior Assistant is present and filed affidavit of the PIO / Sri A. Bhaskar Rao, District Revenue Officer (FAC), O/o the District Collector, Nalgonda District stating that vide letter No: A5/5010/2021 dated: 16-07-2021 the application was forwarded to the PIO / O/o the Project Director, Housing Department, Nalgonda District with a request to furnish the information to the complainant and filed copies of same before the Commission.

Heard the representative of the PIO and perused the material papers available on record.

The Commission directs the PIO / O/o the Project Director, Housing Department, Nalgonda District to furnish the information to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
