Sri Pallela Devaraju, Karimnagar District has filed 2nd appeal dated: 27-10-2021 which was received by this Commission on 29-10-2021 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Karimnagar District and 1st Appellate Authority / O/o the District Panchayat Officer, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 24-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The complainant is absent. The APIO / Sri K. Kranthi Kumar, Junior Assistant, O/o the District Panchayat Office, Karimnagar District is present and filed his affidavit stating that a reply was given to the complainant vide letter No: A5/RTI/2021-Pa dated: 16-09-2021 informing that the information sought to not specific and clear and requested to specify the information sought. The APIO filed copy of the same before the Commission.

Heard the APIO and perused the material papers available on record.

The Commission directs the PIO to give specific point wise reply to the complainant within Ten (10) days from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
