Order

Sri Mohammed Sardar Khan, Hyderabad has filed 2nd appeal dated: 01-11-2021 which was received by this Commission on 01-11-2021 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Nampally, Hyderabad and 1st Appellate Authority / O/o the Regional Joint Director of School Educational Officer, Government of Telangana, Gunfoundry, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 07-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Department what action taken against Fr. Roch Memorial High School, A.C.Guards, Khairatabad, Hyderabad. Complaint Filed and Acknowledgement on 06-05-2021, by the District Educational Officer, & Complaint Filed and Acknowledgement by the Dy. Education Officer, Khairatabad Zone, on 10-05-21 (Above Enclose a letter's given by me)**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 21-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has furnished the information. The APIO / Sri Ch. Rajashekhar, Auditor Cum Superintendent, O/o the District Educational Officer, Nampally, Hyderabad is present and filed his affidavit stating that vide letter Rc. No: 3401/A3/Complaint/2021 dated: 30-09-2021 the application was transferred to the PIO / Deputy Inspector of Schools, Khairtabad Zone, Hyderabad with a request to enquire into the matter and submit a detailed report along with the specific remarks. The APIO filed copies of the same before the Commission.

The PIO / Deputy Inspector of Schools, Khairtabad Zone, Hyderabad is present and filed his affidavit stating that the information was furnished to the appellant vide letter Rc. No: 2019/KBZ/2022 dated: 01-07-2022 and filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on records. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of RTI Act 2005.

Since the appellant himself accepted that he is in receipt of the information, the appeal is closed.
