## **Order**

Sri G. Srinivas Reddy, Hyderabad has filed 2<sup>nd</sup> appeal dated: 02-11-2021 which was received by this Commission on 05-11-2021 for not getting the information sought by him from the PIO / Assistant Secretary to Government, School Education (Ser.II) Department, BRKR Bhavan, Lower Tank Bund, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Principal Secretary, Education Department, Government of Telangana, BRKR Bhavan, Lower Tank Bund, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-02-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

**The Press report on 07-02-2021, in the Front Page and Page No.2, in the "Namaste Telangana", daily News Paper under the title of "BASHA PANDITHULAKU PADONNATULU", sub- title as "Grade-2 Panditulake Grade-1 Postlu", and furnish the following information.**

- "1. The Government of Telangana's G.O.No(s) 2 and 3 issued few days back by way of amendments on the Hon'ble High Court's directions.**
- 2. G.O.No.1 Mandal Parishad.**
- 3. G.O.No.2 Zilla Parishad.**
- 4. G.O.No.278 (Issued in between period of 1995-1996).**
- 5. G.O.No.11 & 12 issued in the year 2009.**
- 6. G.O.No.17, 18 issued in the year 2017 (For the 2, 487 members).**
- 7. G.O.No.15 issued in the year 2019 (For the 6,143 members)".**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 16-09-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. K. Krishna Veni, Assistant Secretary to Government, School Education (Ser.II) Department, BRKR Bhavan, Hyderabad is present and filed her affidavit stating that reply was given to the appellant vide letter No: 4665/SE-Ser-II.A1/2021 dated: 11-08-2021 and vide letter No: 4662/SE-Ser-II.A1/2021 dated: 12-10-2021 informed the appellant that the information sought is not specific / clear and requested to furnish the GO type, Date, Department / Section Name. The PIO filed copy of the letters along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to give a specific reply point wise reply to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
