## Order

Sri B. Parsharamulu, Karimnagar District has filed 2<sup>nd</sup> appeal dated: 10-11-2021 which was received by this Commission on 10-11-2021 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Metpally Village, Shankarapatnam Mandal, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o the Mandal Praja Parishad, Shankarapatnam Mandal, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

మేము మా బిల్డింగ్ మా అమ్మ చెలుకు, నాన్న బాలయ్య, నేను నా బాల్య డీమం 4 గురం బారత రాజ్యోగం అర్బిట్ 20 ప్రకారంగా ఓటు హక్కు కలిగి గత 20 సంవత్సరాలనుండి ప్రభుత్వంలో, ఓటు వేసి ప్రభుత్వాలను గెలుపొంది సయం పడుతున్నాము. వివిధ రూప వస్తులు, చెల్లెస్తులు అని ప్రభుత్వాల, గ్రామ నిజి వచ్చే, ఓటు హక్కు ఉన్న ప్రజలకు రోజుకు 2500 కలిగి రూపాయలు మాకు గత 20 సంవత్సరాలనుండి ఇవ్వడం లేదు. మాకు రోజువారీ లెక్కవోపున కాలాల.

మరియు 2016-2021 వరకు గ్రామ నిజి క్రింది రూపాయలు వచ్చినవి - అందులో నుండి 84,00,000/- Debit బయనవి, ఈ Debit బయన 84,00,000/- ల విషయాల shops బిల్డింగ్లో సహా fake లెకుండు సమాహం నిర్దిత రూపాలలో ఇవ్వగలరు లేనిచో చట్ట పరిమితి, న్యాయపరమైన చెలయి తీసుకోగలను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 17-09-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. K. Rajyalaxmi, Junior Panchayat Secretary, Metpally Village, Shankarapatnam Mandal, Kariminagar District is present and filed her affidavit stating that reply was given to the appellant vide letter No: GP/MTP/RTI/2021 dated: 09-09-2021 requesting to pay Rs. 176/-for Xerox charges and obtain the required information, but the appellant refused to take the information sent through RPAD and was returned to the PIO. The PIO filed copy of the information furnished along with the postal envelope before the Commission.

Heard both the parties and perused the material papers available on record. The PIO submitted that incase the appellant is willing to take the information she is ready to furnish the same. The appellant requested to furnish the information for free of cost. The Commission cannot accept the plea of the appellant.

The Commission directs the PIO to furnish the information to the appellant only after paying the requisite fee duly attesting through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
