Order

Sri K. Madhusudhan Reddy, Medchal Malkajgiri Dsitrict has filed a Complaint dated: 02-11-2021 which was received by this Commission on 12-11-2021 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Educational, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri G. Parmeshwar, Assistant Director, O/o the Commissioner and Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 595/RTI/2021 dated: 24-09-2021 the application was transferred u/s 6(3) of the RTI Act to the PIO / O/o the District Educational Officer, Medchal – Malkajgiri District with a request to furnish the information to the appellant. The PIO filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The PIO submitted that the PIO / O/o the District Educational Officer, Medchal – Malkajgiri District vide letter Rc. No: 2091/A3/RTI/2021 dated: 22-10-2021 transferred u/s 6(3) of the RTI Act to the PIO / Mandal Educational Officer, Ghatkesar / Medipally of Medchal – Malkajgiri District with a request to furnish the information to the appellant.

The Commission directs the PIO / Mandal Educational Officer, Ghatkesar / Medipally of Medchal – Malkajgiri District to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
