Order

Sri Mohd Ashraf, Sirpur-Kagaznagar District has filed 2nd appeal dated: 10-11-2021 which was received by this Commission on 15-11-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 11-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. 2. మీ కార్యాలయం ద్వారా 01-01-2010 నుండి నేటి వరకు MLA, MP, స్థానిక సంస్థల MLC, TEACHERS MLC, GRADUATE MLC తదితర నిధులు వారికి ప్రభుత్వం కేటాయించిన నిధుల వివరాలు వాటిని ఖర్చు చేసిన వాటి వివరాలను జిల్లా ఏర్పడినప్పటి నుండి నేటి వరకు ఇవ్వగలరు.
3. మీ కార్యాలయం ద్వారా 01-01-2010 నుండి నేటి వరకు RURBAN, SC ST SUB PLAN, MINORITY, CORPORATE RESPONSIBLE FUND, ROYALTY తదితర నిధులు ఏ ఏ కాఖకు ఎంత ఎంత కేటాయించినారో జిల్లా ఏర్పడినప్పటి నుండి నేటి వరకు తెలుపగలరు.
4. 2014 నుండి నేటి వరకు RTI Act లోని సెక్షన్ 19 (1) ప్రకారం Supreme Court తీర్పు నెంబర్ 436 of 2018 Dated: 15.02.2019 ప్రకారం మీరు ఇచ్చిన తీర్పుల ప్రతులు ఇవ్వగలరు.
5. మీ కార్యాలయం ద్వారా 01-01-2010 నుండి నేటి వరకు ప్రభుత్వ నిధులు లేదా place పొందిన NGOs , Trusts లు Accounts Of All Sums Of Money Received And Expended By The Society, Cash Book, Receipt Book, Vouchers, Ledgers, Audit reports లను ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 03-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is absent. The APIO / Sri K. Bapu, Revenue Officer, O/o the Municipal Commissioner, Kagaznagar Municipality, Komaram Bheem Asifabad District is present and filed his affidavit stating that reply was given to the appellant vide letter No: RTI/92/2021 dated: 05-11-2021 to visit their office on any working day and obtain the required information, since the appellant did not visit their office, the said information was not furnished. The PIO filed copy of the covering letter before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has given a reasonable opportunity to the appellant, but the appellant failed to utilize the same.

The Commission gives a final opportunity to the appellant and directs the PIO to allow the appellant for verification of records on a mutually fixed date and time and furnish the required or give point wise reply to the appellant as sought by the appellant through his 6(1) dated: 11-08-2021 through registered post with acknowledgement due & to report compliance.

With the above direction, the appeal is closed.
