## **Order**

Sri M. Guruprasad, Mirmal District has filed 2<sup>nd</sup> appeal dated: 27-01-2022 which was received by this Commission on 01-02-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Nirmal Collectorate, Nirmal District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Nirmal Collectorate, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Complete log book details of House no 1-1-20 with all details as 1100004781 of citizens Nirmal
- 2) Complete Property Tax details of House no 1-1-20 citizens Nirmal from 2000 to 2021 in the form of Xerox copies
- 3) Any name changes occur in the property Tax of House no 1-1-20 citizens Nirmal occur or not if changes occur please provide what are the changes occur in Tax from 2000 to 2021

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 27-12-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 12.00 P.M.

The case is called on 25-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished incomplete information. The APIO / Sri T. Gangadhar, Revenue Officer O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District is present and filed affidavit of the PIO / Dr. P. Rambabu, District Revenue Officer (FAC), O/o the District Collector, Nirmal District stating that vide letter No: RTI/A6/4/2021 dated: 30-11-2021 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District with a request to furnish the information to the appellant and vide letter No: A1/RTI Act 2005/2021 dated: 31-01-2022 the said information was furnished by the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District. The APIO filed copies of the reply given to the appellant before the Commission.

Heard both the parties and perused the material papers available on record. The APIO further submitted that the appellant vide letter dated: 18-08-2022 stated that he is receipt of the information.

Since the information is furnished, the appeal is closed.
