## **Order**

Sri Kartheek Repala, Hyderabad has filed 2<sup>nd</sup> appeal dated: 09-11-2021 which was received by this Commission on 16-11-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Thipparthi Mandal, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nalgonda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) The present status of the updation of Khata number 869, Survey No : 624k Rajupeta Village, Thipparthy Mandal online.
- 2) The reasons as per the records for the delay in updation of Khata number 869, Survey No: 624k Rajupeta Village, Thipparthy Mandal online.
- 3) Certified copy of the actions taken on the Grievance (NLGDC/E/2021/02071) for the above matter.

and more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 06-10-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The appellant is present and filed his affidavit stating that the PIO has furnished the information. The APIO / Sri B. Narahari Prasad, Mandal Giridwar, O/o the Tahsildar, Thipparthi Mandal, Nalgonda District is present and filed his affidavit stating that the information was furnished to the appellant by hand vide letter No: D/793/2021 dated: 25-11-2021 and filed copy of the same along with the acknowledgement of the appellant before the Commission.

Heard both the parties and perused the material papers available on record.

Since the appellant himself accepted that he is in receipt of the information, the appeal is closed.
