## Order

Sri Vibhudi Venkateshwarlu, Ranga Reddy District has filed 2<sup>nd</sup> appeal dated: 15-11-2021 which was received by this Commission on 16-11-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Gundlapally (Dindi) Mandal, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Devarakonda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① ఆంధ్రప్రదేశ్ రాష్ట్రం సాక్షి నెం. 335/81 మరియు 335/81 లోని ప్రాసిడింగ్ మరియు ఇతర పత్రములు తెలియజేయవలెను.
- ② ఈ పత్రములు ఉపయోగించి ఆంధ్రప్రదేశ్ రాష్ట్రం సాక్షి నెం. 335/81 నందు సాక్షి నెం. 335/81 కింద AC. 1-00 లోని గ్రామీణ శాసనసభ సమావేశాలు, నిర్ణయాలు, సమావేశాల ప్రాసిడింగ్ ను తెలియజేయవలెను. ఏంజి. నెం. 2006-2021 వరకు సాక్షి నెం. 335/81 నందు తెలియజేయవలెను.
3. సాక్షి నెం. 335/81, గ్రామీణ శాసనసభ సమావేశాలు 2006-10 కింద 87వ చట్టం నం. 29 కింద తెలియజేయవలెను. దీనిని సాక్షి నెం. 335/81 నందు తెలియజేయవలెను. Registered Doc. మరియు proceedings ను తెలియజేయవలెను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 12-10-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The representative of the appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri R. Gopa Raju, Mandal Revenue Inspector, O/o the Tahsildar, Gundlapally (Dindi) Mandal, Nalgonda District is present and filed his affidavit requesting to give time to furnish the information.

Sri K. Mahesh Babu, Senior Assistant is present on behalf of the First Appellate Authority / Sri K. Gopiram, Revenue Divisional Officer, Devarkonda Division, Nalgonda District and filed his affidavit stating that vide letter No: C/138/2021 dated: 24-11-2021 the appellant and the PIO were directed to appear before the First Appellate Authority on 03-12-2021 and order was passed directing the PIO to furnish the information to the appellant within One week.

Heard both the parties and perused the material papers available on record. The Commission is of the view that even after the direction given by the First Appellate Authority, the PIO failed to furnish the information to the appellant.

The Commission directs the PIO to furnish the complete information or give a specific reply (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO & the then PIO / Sri K. Narasimha Rao, Deputy Tahsildar, Gundlapally (Dindi) Mandal, Nalgonda District for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7 (1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
