Order

Sri G. Vijay Kumar, Ranga Reddy District has filed 2nd appeal dated: 22-11-2021 which was received by this Commission on 23-11-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 06-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

5. నామినేషన్ పద్ధతిలో కేటాయించడానికి గల కారణాలు వివరిస్తూ పనుల కేటాయింపు ఆనుమతుల ప్రతులను జరపరుస్తూ మేము కోరిన రూపంలో సమాచారం ఇవ్వగలరు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 18-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 31-03-2022 and 06-07-2022.

The case is called on 06-07-2022. The appellant is absent. The APIO / Sri K. Bapu, Revenue Officer, O/o the Municipal Commissioner, Kagaznagar Municipality, Komaram Bheem Asifabad District is present and filed his affidavit stating that vide letter No: RTI/34/2022 dated: 05-07-2022 the information sought is ready and brought to the Commission to furnish the same to the appellant. The PIO filed copy of the covering letter before the Commission.

Heard the APIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of RTI Act 2005.

The Commission directs the PIO to furnish the complete information to the appellant immediately on receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
