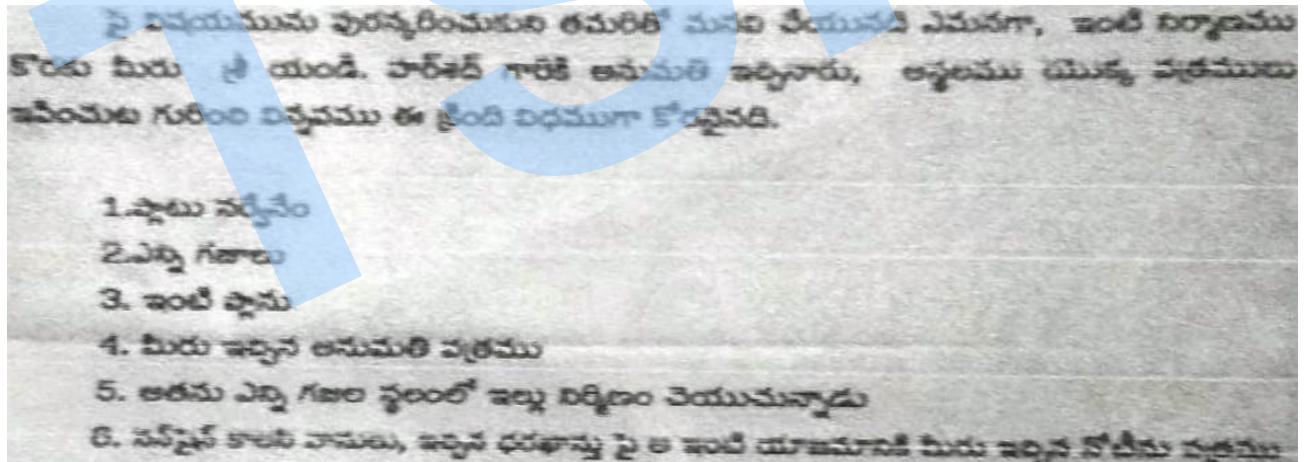

Order

Sri Ch. Narender, Sangareddy District has filed 2nd appeal dated: 20-11-2021 which was received by this Commission on 23-11-2021 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Kalabgur Village, Sangareddy District and 1st Appellate Authority / O/o the Mandal Parishad Development Officer, MPP, Sangareddy Mandal & District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-04-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:



Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 20-06-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is absent. The PIO / Sri K. Bikshapati, Panchayat Secretary, Kalabgoor Gram Panchayat, Sangareddy District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: 01/2021/RTI dated: 05-07-2021 and filed copies of the same along with the postal receipt before the Commission.

The First Appellate Authority / Smt. N. Praveena, Mandal Panchayat Officer, MPP, Sangareddy District is present and filed her affidavit stating that a hearing was conducted on 07-08-2021 and 11-08-2021 and enquiry was conducted. The First Appellate Authority filed copies of the letters before the Commission.

Heard the PIO and the First Appellate Authority and perused the material papers available on records and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
